WIS 67 Western County Line to Eastern County Line  
Fond du Lac County

Dear Chairman Thompson:

The Wisconsin Department of Transportation (WisDOT) Northeast Region will conduct a public involvement meeting to discuss the proposed improvements to WIS 67 from the western county line to the eastern county line in Fond du Lac county. The meeting will be held on Thursday, March 1, 2018, from 5:30 to 7 p.m. at the Osceola Town Hall, W1476 County Road F, Campbellsport, WI 53010. A short presentation will be made at 5:45 p.m. Representatives of the WisDOT will be available to discuss the proposed project and address any questions or concerns. A project location map is attached.

WIS 67 in Fond du Lac County is primarily a rural two-lane facility, except for an urban section through the village of Campbellsport. The project includes four separate construction projects, combining to include the entire length of WIS 67 in Fond du Lac County.

The project in Campbellsport will be a full reconstruction of WIS 67 with new pavement, curb and gutter and sidewalk where necessary. Some modifications to the alignment and profile are proposed for the east side of the Village. The project will include new storm sewer, sanitary sewer and water main.

The other three projects will include milling of the existing pavement and the application of a new surface layer. No changes to alignment or profile are expected for these projects, with the exception of a realignment of the intersection of WIS 67 and US 45. Beam guard will be replaced where warranted. Cross drains will be extended or replaced as needed. Intersections between WIS 67 and other roadways will see minor improvements, but the functional area of these intersections is not expected to expand. Some small areas of property acquisition will be needed to construct the project.

Structure work along this corridor includes the replacement of the deck of the Milwaukee River Bridge in the Village of Campbellsport, and the replacement of a box culvert just east of the intersection of WIS 67 and US 45. The replacement of the Virgin Creek Box Culvert is scheduled for construction in 2018. The resurfacing projects are scheduled for construction in 2019 and 2020. The reconstruction project in the Village of Campbellsport is scheduled for construction in 2021.

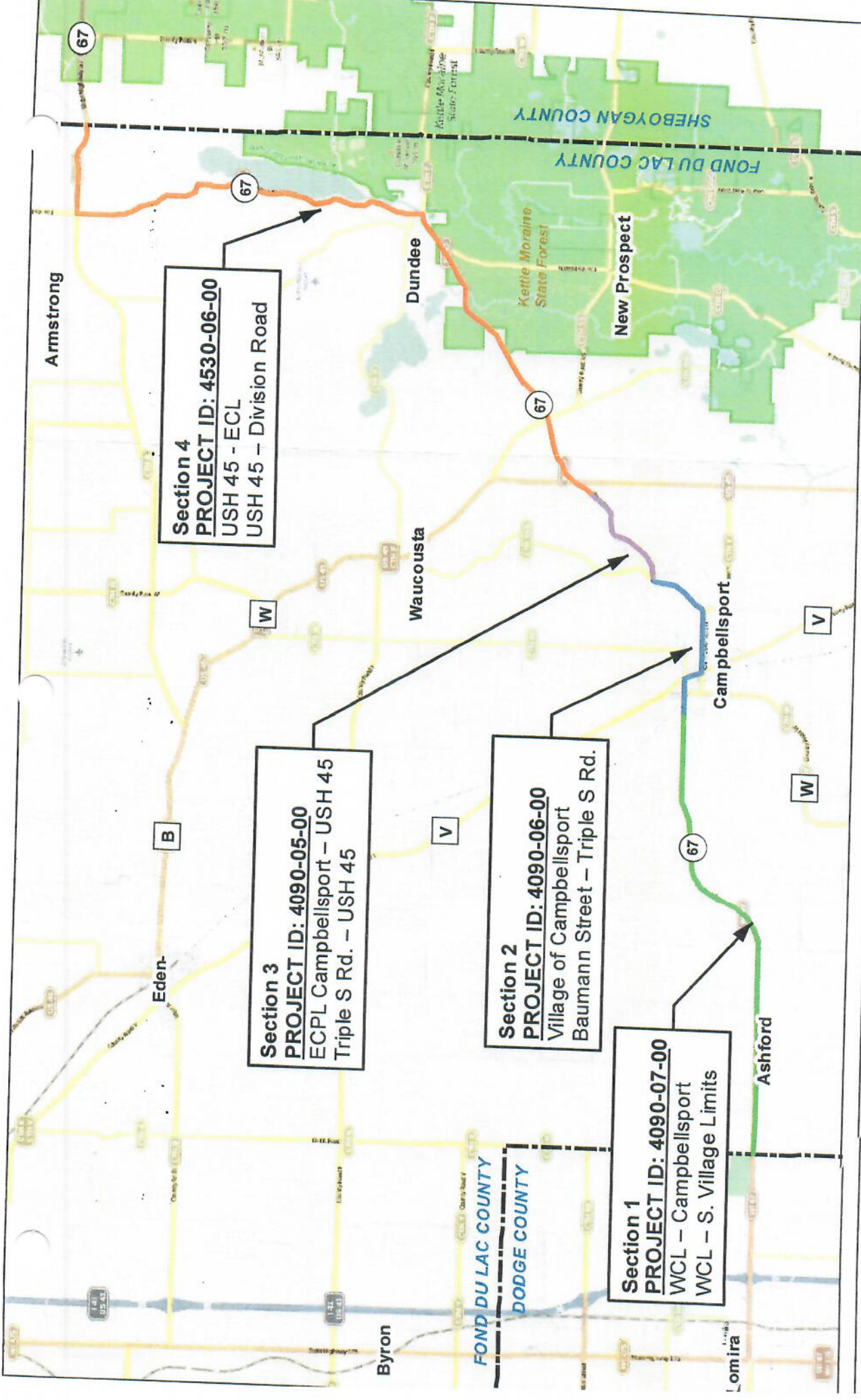
