Elections will be held at the June General Meeting. KMLA will see some changes in leadership. Dave Katt, current president will run for president again with the stipulation that he will assume the position (if elected) only if someone will share the position with the intent to run for president in 2022. He is willing to bring someone up to speed on the information needed for this position over the next 2 years.

Hello Fellow Lake Residents, Friends and Neighbors,

Another summer has come to an end, piers are out and winter is about to begin.

I hope everyone was happy with the quality of our lake this year. I know Cindy and I sure were! The treatment plans that were created over last winter with the DNR and our Lake Management Company, Onterra worked better than we anticipated. In the fall survey completed by Onterra, virtually no Eurasian Water Milfoil (EWM) was found in the lake. The first time in over 15 years that the levels of EWM have been this low.

As you may know treatment plans for our lake are now done on a multi-year schedule. Gone are the days of the DNR allowing us to treat the lake every year. In its place we need to negotiate a series of yearly plans that can be executed should certain trigger points measuring the amount of EWM present be met. Next summer - the second year of the current plan, if the trigger point is met, we will contract for the use of Diver Assisted Suction Harvesting (DASH) to remove as much material as possible.

In the third year, again if trigger points are met, spot treatments may be allowed. In the final year we will review the status of the lake and negotiate the next 4-year plan. The process will then restart. The negotiation process with the DNR is time consuming and many times frustrating. By the time the process starts again 2022/2023 I hope that others from around the lake will take over.
