Ice Bike Race

The steel shoe ice bike race will NOT be held on Kettle Moraine Lake this year. It will be held on January 29 2023 at Sunset on the Water Bar & Grill on Lake Winnebago.

Kettle Moraine Lake - Deep Hole was sampled **9** different days during the 2022 season. Parameters sampled included:

• water clarity, temperature, dissolved oxygen, total phosphorus, chlorophyll

The average summer (July-Aug) secchi disk reading for Kettle Moraine Lake - Deep Hole (Fond du Lac County, WBIC: 43900) was 11.5 feet. The average for the Southeast Georegion was 6.2 feet. Typically, the summer (July-Aug) water was reported as **CLEAR** and **GREEN**.

Chemistry data was collected on Kettle Moraine Lake - Deep Hole. The average summer Chlorophyll was 2.4 μ g/l (compared to a Southeast Georegion summer average of 24 μ g/l). The summer Total Phosphorus average was 15.1 μ g/l. Lakes that have more than 20 μ g/l and impoundments that have more than 30 μ g/l of total phosphorus may experience noticeable algae blooms.

The overall Trophic State Index (based on chlorophyll) for Kettle Moraine Lake - Deep Hole was 41. The TSI suggests that Kettle Moraine Lake - Deep Hole was **mesotrophic**. Mesotrophic lakes are characterized by moderately clear water, but have an increasing chance of low dissolved oxygen in deep water during the summer

Kettle Moraine Lake Eurasian Watermilfoil (EWM) Update and Control Plan

Why control EWM?

- Its dense nature displaces water for beneficial wildlife.
- -It reduces the aesthetic quality of the lake.
- -It litters shorelines with plant fragmentation.
- -It creates difficult and dangerous swim areas.
- -It shunts fish life and habitat.
- It creates tangling and damage to boat motors and clogging of systems.
- -It chokes out boat and watercraft navigational lanes.

What are we doing about it?

After reviewing our results from effectively treating a 10-acre plot in 2021 with ProcellaCOR, we worked closely with the DNR and our lake management team from Onterra to design a plan for 2022. This plan was formed using data collected from surveys performed by Onterra as well as water sample evaluations retrieved by volunteers and tested at a lab. We then acquired the necessary permit and on June 3rd, 2022, Clarke Aquatic Services conducted an herbicidal treatment of ProcellaCOR on a 13-acre plot on the west side of the lake as well as a 5-acre plot in the area surrounding the beach and boat launch. A map of the treatment areas can be found on our website by going to kettlemorainelake.org and selecting Lake Care. Select Invasive Species and you can view the permit application which contains the map. The areas outlined in black on the map are the areas we treated.

The goal of this year's herbicidal application was to have increased results outside of the specific treatment areas. We are pleased to report, the plots chosen, as well as some slight modifications made to the herbicidal concentration, successfully resulted in that outcome.

On September 27th, Onterra performed a whole lake survey. The results from that survey will be used to design a plan for 2023. That plan could include herbicidal treatment, mechanical harvesting, or possibly a combination. We will work closely with the DNR to determine our next steps.

EWM control requires substantial funds to manage. We were able to use funds remaining in our existing grant to cover a portion of monitoring and survey costs, however the remaining portion as well as the herbicidal application costs were the responsibility of the association. On September 15th, we sent in a pre-application to pursue an Aquatic Invasive Species Control Grant. A final draft of our application is due November 15th, 2022. If we are to acquire this grant, those funds would be for use in 2023. The specifics of the grant have yet to be determined as we will still need to get the DNR's approval for our 2023 plan.
