## RESOLUTION REPEALING AND REPLACING CHAPTER 58, FOND DU LAC COUNTY PRIVATE ONSITE WASTEWATER TREATMENT SYSTEMS (POWTS) ORDINANCE

WHEREAS, this Article of Code is now in need of major revisions, due to the inconsistencies found from an enforcement standpoint and providing an inaccurate representation of the Private Onsite Wastewater Treatment Systems (POWTS) from a regulatory standpoint, and

WHEREAS, these changes require the repeal and replacement of Chapter 58, Private Onsite Wastewater Treatment Systems (POWTS) of the Fond du Lac County Code of Ordinances, and

WHEREAS, after a thorough review, a replacement Chapter 58, Private Onsite Wastewater Treatment Systems (POWTS) of Fond du Lac County is being submitted for adoption.

**NOW, THEREFORE, BE IT ORDAINED** by the Fond du Lac County Board of Supervisors to repeal the existing Private Onsite Wastewater Treatment Systems (POWTS) Chapter 58, County Code, and replace Chapter 58 as attached.

**BE IT FURTHER ORDAINED** that the recreated replacement Fond du Lac County Private Onsite Wastewater Treatment Systems (POWTS) chapter will become effective upon completion of the required legal notice.
