The Fond du Lac County Sheriff's Office has been notified that **Adam J. Ebert** will be residing at **W1828 Woodland Drive**, in the **Town of Osceola**, on or around November 14, 2023 after being released from the Oshkosh Correctional Institution. In 2008, **Adam J. Ebert** sexually assaulted a 15-year-old female victim known to him. In 2011, **Adam J. Ebert** randomly sent text messages to a 15-year-old indicating he was 18 years old. When **Adam J. Ebert** met with the victim, he acknowledged he was 25 years and subsequently sexually assaulted the 15-year-old victim.

**Adam J. Ebert is on extended supervision until November of 2031. Special conditions of Adam Ebert's supervised release include:**

- 1) Comply with requirements of lifetime Sex Offender Registration.
- 2) Comply with requirements of lifetime GPS monitoring.
- 3) Comply with rules established by the Division of Community Corrections.

### SEX OFFENDER INFORMATION BULLETIN

The Fond du Lac County Sheriff's Office is releasing the following information pursuant to Wisconsin State Statute 301.45 and 301.46 (Act 440), which authorizes law enforcement agencies to inform the public of a sex offenders release when, at the discretion of the agency, ***the release of information will enhance public safety and protection.***

The individual who appears on this notification has been convicted of a sex offense that requires registration with the local law enforcement agencies. Further, his previous criminal history places the offender in a classification level which reflects the potential to re-offend.

This sex offender **has served** the sentence imposed on him by the courts and has advised Wisconsin Department of Corrections Sex Offender Registry that he will be living at the location on the opposite side of this flier. **THIS PERSON IS NOT WANTED BY LAW ENFORCEMENT AT THIS TIME.** THIS NOTIFICATION IS NOT INTENDED TO INCREASE FEAR; RATHER, ***IT IS OUR BELIEF THAT AN INFORMED PUBLIC IS A SAFER PUBLIC.***

Sex offenders **have always** lived in our communities but it was not until the passage of Act 440 (which mandates sex offender registration) that law enforcement even knew where they were living. There are currently more than 26,000 sex offenders on the Wisconsin Sex Offender Registry, and approximately 300 living in Fond du Lac County alone. In many cases, law enforcement is now able to share information about these offenders with you. Citizen abuse of this information used to threaten, intimidate, or harass registered sex offenders will not be tolerated, and doing so could potentially end law enforcement's ability to conduct these notifications in the future.
